

AVITA THERAPEUTICS, INC. (ASX:AVH)

Cleansing Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

Valencia, Calif., USA, and Melbourne, Australia, 10 September 2020: On 9 September 2020 (Pacific Time), AVITA Therapeutics, Inc. (**Company**) issued a total of 83,333 fully paid shares of common stock in the Company (**New Securities**) to the Company's Chief Executive Officer, Dr Michael Perry, as a result of the vesting of 8,333,334 unquoted restricted stock units in AVITA Medical Limited (**Avita Australia**) (which entitled Dr Perry to be issued shares of common stock in the Company rather than ordinary shares in Avita Australia on a consolidation ratio of 100:1 as set out in the Company's pre-quotations disclosure released to the market on 24 June 2020).

The New Securities will be quoted on NASDAQ, but may be converted into CHESSE Depository Interests (**CDIs**) in the Company quoted on ASX at any time by the relevant holder. The Company seeks to rely on an exemption under section 708A of the *Corporations Act 2001 (Cth)* (**Corporations Act**) with respect to the sale of any CDIs which are issued on conversion of the New Securities (in the instance that such conversion occurs).

The Company gives this notice under section 708A(5)(e) of the Corporations Act as modified by ASIC Class Order 14/827 and ASIC Instrument 20-0599.

The New Securities were issued without disclosure to investors under Part 6D.2 of the Corporations Act.

As at the date of this notice, the Company has complied with:

- the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
- section 674 of the Corporations Act.

As at the date of this notice, there is no information that is 'excluded information' within the meaning of section 708A(7) and section 708A(8) of the Corporations Act.
